## Expected impact (2014-2020)

Expected impact of our participation in the Erasmus Programme on the modernization of our institution in terms of the policy objectives we intend to achieve.

Below we explain the some activities that will take place to implement the objectives of our educational institution and the expected impact of those activities

## **Objective 1 Increasing educational attainment levels**

#### Activities

- a. Students who have done individual mobility will explain their experience to other students and the benefits they have
- earned by their work placement in foreign countries
- b. We will provide visibility of the number of students who have got a job in foreign countries after individual mobility

#### Expected impact

- I. Reducing the dropout rate in Higher Level Training Cycles, which is currently 15% of students and we hope to reduce to less than 10%
- II. 100% of students using the Europass as job search and recognition of their professional and language skills.
- III. Increasing the percentage of students who get job after graduation.

## **Objective 2 Improving the quality and relevance of higher education**

#### Activities

- a. Student and staff will show new technologies to be used in the teaching and learning process and are useful for the future
- b. Staff training in new technologies, language learning and diversity

#### Expected impact I.

- Increasing the number of staff in language training.
- II. Increasing the number of teachers in bilingual education. Currently there is a 4% of teachers and we want to reach 10%.
- III. Increasing the number of students who want to do bilingual education in our institution. Currently is 2% and our goal is to reach 8%

# **Objective 3 Developing a sense of belonging to the E.U. and international cooperation**

#### Activities

- a. We will offer to Short Cycles students individual mobility
- b. We receive teachers from other countries who collaborate with us. We want them to participate
- in the classroom to show the feeling of belonging to the E.U. and international cooperation
- c. We will encourage all staff to participate in European Programmes

#### Expected impact I.

- Our educational institution has 100 students who are in the last year of a Short Cycle. Now 15% of those students do individual mobility and we want to reach a 20%.
- II. Our educational institution receives every year 2 or 3 foreign teachers. We want to keep and improve this cooperation

III. Over the past five years, every year 2 or 3 of our staff has taught andor trained in educational institutions or companies in other countries. We expect increase the number of staff mobility

### **Objective 4 Linkage between education, research and innovation**

#### Activities

a. Propose to students in personal mobility to conduct a research project based on their experience in work placement
